INDUCTION AND TRA	AINING				
Applicants will be assessed against the Scheme requirements for auditors/mentors in their location. Where new auditors /mentors are required in an area selected applicants will be invited to an interview. Before commencing work as a SALSA mentor or receiving allocated work from SALSA as an auditor, successful applicants must attend a one-day induction seminar. There will be no charges for attendance; travel costs will be at the applicant's own expense. Thereafter, every mentor and auditor will be required to attend one day (or equivalent) SALSA auditor and mentor training seminar per year and complete alignment activities as required. The induction and annual training will contribute to the IFST register annual CPD requirements. There may be additional pre-qualifications/training to undertake certain activities for SALSA
